## Main Findings of Monitoring

29.07 –15.08

This monitoring covers the period from 29 July to 15 August and has revealed the following tendencies:

### MONITORING

- Main topics of the reported period were a court trial of religious servants participating in the break up of the rally against homophobia and transphobia on 17 May; and a campaign No to Same-Sex Marriage initiated by the Christian-Democratic movement as part of its pre-election campaign;
- The coverage of the court trial by media was unbalanced, providing positions of religious servants and their supporters alone; the position of prosecution was not reported at all. None of media outlets have provided footage featuring the episode of acquittal of one of religious servants, whilst some media outlets (Channel 9, Kavkasia TV) described this episode in a text incompletely, focusing on swearing by the priest alone and not threats made by him (“I will kill you...”) which was featured in a video released via social networks and some TV channels;
- Anti same-sex marriage campaign of the Christian-Democratic movement was covered without a critical approach;
- Racist statements were made by journalists (newspapers Kviris Kronika, Asaval-Dasavali);

## Main Findings of Monitoring

- Anti-Turkish attitudes were observed in relation to not only concrete persons but also the assembling of a minaret in the village of Chela, Adigeni district (Asaval-Dasavali newspaper);
- Discriminative statements about the sale of land to foreigners were made by religious servants (Davit Isakadze, Union of Orthodox Parents) and politicians (Koba Davitashvili, a presidential candidate); a clear cut editorial stance in this regard was revealed by *Rezonansi* newspaper in which the vision favoring the restriction of the sale of lands to foreign citizens dominated the materials published on this topic – be they articles, columns or comments of separate persons, with the opposing view rarely provided;
- A report of Imedi TV concerning a suspect in murder being an Iranian citizen can be regarded as the incitement of hatred on religious ground (see MDF’s statement). Even though the TV company responded to a statement of the Georgian Muslims’ Union via social networks, the TV company did not correct the misleading information in a due manner as required by the Code of Conduct for Broadcasters and indicated in the MDF’s statement dated 3 August;
- Maestro TV’s inquiry into a conduct of traditional Muslim prayers after the incidents in the village of Samtatskaro was an example of positive coverage, as well as reports by Maestro and Imedi TV on Ramadan Bayram;
- An issue of sexual minorities was again exploited in a political context – alongside the United National Movement, the Republican Party was also mentioned in this regard;
- Gender discrimination was seen on the part of both respondents (Georgian Dream MP Zakaria Kutsnashvili) and journalists (*Kviris Kronika* newspaper).

## MDF statement regarding the TV story aired by "Qronika" on August 1

3 August, 2013

Media Development Foundation, MDF expresses its concern regarding the TV story aired on August 1 in news at 20:00 by the TV Company “Imedi,” concerning the murder of Mariam Kochalidze in Batumi, stating that this murder was committed on religious ground. Without verifying the information, the editorial aired the statement of victim’s mother made on emotional background and stating that the alleged murderer conducted the ritual of sacrifice.

We welcome the fact that the TV Company “Imedi” responded to the address of the Georgian Muslims’ Union calling on media to avoid spreading unchecked, one-sided information that could encourage hatred and promote negative stereotypes related to Islam. However, we believe



that the response of the TV Company was not sufficient due to the following circumstances:


TV company “Imedi” in the statement sent to Media.ge dissociates itself from the assumption expressed by Mariam Kochaladze’s family members and notes that it does not represent the position of TV “Imedi”. It is also noted in the statement that “neither news anchor, nor the journalist have attempted to interpret this version” which in our view is incorrect because in the brief news of “Qronika” at 20:00 the anchor of the news program announced without indicating the source: “The ritual of sacrifices and conflict on religious background. New details in the crime story from Batumi”. By this statement, the editorial assessed the incident which is being investigated, as a religious conflict and offered sacrifice as a confirmed fact.

TV company violated the regulations of the articles 13 (1,2) and 14 of the Code of Conduct for

## The court trial of religious servants

Anthimos Bichinashvili on May 17 Counter-Rally

The media coverage of the court trial of two clergymen and three civilians, charged for violently thwarting a planned peaceful rally to mark the international day of fight against homophobia and transphobia on 17 May, was again dominated by positions of the defense and supporters of the clergymen. An exception was only Imedi TV company which covered the acquittal of Archimandrite Anthimos Bichinashvili and the resumption of the trial against other persons on 15 August, only by short actuality, without any comments.

Every TV channel noted that the judge deemed materials presented in the case as insufficient evidence against Anthimos Bichinashvili whilst Channel 9 and Kvakasia TV said in journalists' texts that the video footage in the court case included episode showing how this religious servant was swearing. None of media outlets released the video showing this episode, in which Anthimos Bichinashvili was not only swearing but also threatening participants of the rally ("I will kill you..."), thus allowing viewers to evaluate the reliability of arguments presented at the court trial.

Media outlets did not provide the position of the prosecution and did not inquire whether the state prosecution intended to appeal the acquittal of one of the charged persons with a higher court.

## Same-sex Marriage in Electoral Discourse

An initiative of the leader of Christian-Democratic Movement, Giorgi Targamadze, to collect signatures for a constitutional amendment for legalizing traditional marriages and, as Targamadze declared, preventing same-sex marriages, was covered by news programs in an identical manner. The only exception was a report in the Imedi TV news program on 6 August, which along with the positions of the initiator of the issue and politicians, provided the positions of the Georgian Young Lawyers' Association and the defender of LGBT rights, the Identoba NGO.

None of media outlets has noted in the background information that the legalization of same-sex marriage has never been put on the agenda in Georgia and no group has ever made such a demand. Journalists have not even put a question on this hypothetical issues to initiators of the prohibition of same-sex marriage either, which is an example illustrating that media spreads information on any issue which it is offered without any criticism.

Moreover, at a meeting in Kobuleti, Girogi Targamadze unjustifiably linked the issue of same-sex marriage with Georgian fighters killed in Abkhazia and Shida Kartli.

## Ethnic Minorities

### GPB and Rustavi 2, 10 August

News programs of both TV companies portrayed a conflict between Adjarian ecomigrants of the Tiva village and ethnic Dagestanis of the Mtisubani village (Kvareli ditrikt) on various daily issues (pig growing, putting up a sign) and on the selection of a place for erecting a cross, as an ethnic conflict. A GPB presenter, in presenting the report underlines, among other motives, a religious ground of the conflict, thereby dramatizing the situation. It would be desirable for the anchor, when presenting a sensible issue, to limit herself to reporting claims of the parties alone. The GPB report also noted that the Minister for Reintegration got involved in the settlement of the conflict, but it did not provide the position of the minister.

Alike Imedi TV (see, the MDF statement concerning the report of Imedi TV news program), a material published by the newspaper regarding the killing of Mariam Kochaladze, in committing which an Iranian citizen is accused, names a religious sacrifice as one of the motives of the crime. It is noteworthy that this theory, which belongs to a godmother of the deceased person who speaks about that being under emotional stress, also includes a xenophobic statement towards Iranians in general.

**Nato Kvintradze, Mariam Kochaladze's godmother:** *"We demand that no Iranian enter Georgia... Mariam was a pure Christian. I think the murdered sacrificed her."*

No doubt that any theory has the right to exist but a journalist must refrain from directly spreading emotional statements and take reasonable precautions to verify such assumptions, including, by approaching investigative bodies.

Based on the above mentioned materials, a journalist engages in unfounded generalization of Turkish expansion in Georgia and incites anti-Turkish sentiments.

The title of the article itself, "Assemblage of 24-meter-high minaret rapidly and cheaply, or who incites religious conflict in Adigeni?!", is offensive towards Muslim citizens of Georgia.

## Sexual Minorities

Gela Zedelashvili's article "Why LGBT defenders sue the minister of health care?" is about a claim filed with the constitutional court, in which they demand the annulment of the order of the health minister which restricts the blood donation from homosexuals. The article is entirely homophobic and portrays homosexuals as diseased people.

The article is about a resolution of the US association of psychologists, according to which psychotherapists are prohibited from recommending homosexuals to cure homosexuality, which is followed by a homophobic evaluation by the journalist:

**Mikheil Sakhvadze, journalist:** "...In other words, to persuade [homosexual patients] that homosexuality is not a problem at all and that they are ordinary members of the society. Thus, if we share the fate of Sodom and Gomorrah, then we must not be surprised about anything!"

## Gender Issues

A protest of an independent feminists group against the issuance of certificates by Levan Samkharauli Bureau of Expertise for the aim of detecting a virginity of a woman, was covered in news programs of Maestro, Imedi and Channel 9. The group was voicing its protest against the institutionalization of the breach of women’s right.

Reports aired by Imedi TV and Channel 9, included, among others, a comment by the chairman of the Georgian Dream parliamentary faction which is discriminatory in terms of gender.

**Zakaria Kutsnashvili, Georgian Dream:** “I think that the main certificate of virginity is that issued by a husband. The husband is the key person issuing this certificate and therefore, if the husband,

## MDF statement regarding the TV story aired by "Qronika" on August 1

Broadcasting obliging broadcasters to ensure the reliability of sources and accuracy of facts, to prevent airing of incorrect or misleading information; Also there was the violation of the regulation 2 of Article 18, which states: "The program or report will be considered biased if it lacks comprehensive information on important facts, is based on minor facts, misleads the audience intentionally or unintentionally, or conveys biased views of a person in a hidden form."

The editorial did not take reasonable steps to verify the accuracy of the facts reported. The crime committed on religious backgrounds is an aggravating circumstance by the Georgian legislation, however the journalist had not rechecked with official investigation the version provided by the victim's parent and addressed for the comment the victim's godmother. The Code of Conduct for Broadcasters obliges a broadcaster to recheck information with at least two separate sources: "Broadcasters, as far as practicable, should rely on first hand sources and gather information themselves. As a rule, broadcasters should not rely on a single source but seek to obtain information from other sources." The emotional condition of the victim's family members is natural and understandable, but media should be very careful with the expressions made in such circumstances and air such sensitive topics only after rechecking the facts, in order to avoid misleading the audience.

In addition the news program of TV "Imedi" violated Article 31 of the Code of Conduct for Broadcasters, stating that "Broadcasters shall refrain from publishing any material likely to incite hatred or intolerance" on the grounds of religious convictions, as well as the Article 33. According to the regulation 1 of Article 33 "Broadcasters should avoid drawing unjustified parallels between ethnic or religious origin and negative events, including associating activities of specific individuals with the entire group." In case of TV "Imedi" the incident was qualified as a religious conflict in a completely unjustified manner.

Taking into account the numerous facts of violation of the regulation of the Code of Conduct for Broadcasters, we believe that the respond of the TV company 'Imedi' to the appeal of Georgian Muslims' Union is insufficient. We call on this TV media:

- To correct important factual mistakes publicly and immediately through a proportional means and forms, scheduled appropriately, as required by the Article 13 (3) of the Code of Conduct for Broadcasters.

And we call on media:

- Report on such sensitive themes with more accuracy and protect the norms and regulations stated in the Code of Conduct for Broadcasters aimed at ensuring "that any broadcasting licensee and especially, the public broadcaster be equally responsible for observing standards of professional ethics and be accountable to the public as being necessary to protect ethics and human values, strengthen social consensus and promote tolerance in a democratic society".
