Monitoring Findings

The following tendencies have been observed for the reporting period – April 29 – May 6:

- A clear line between discriminations on the grounds of ethnicity, religion or sexual orientation was often difficult to draw as all these forms of discrimination were mainly applied intermittently, by respondents and sometimes journalists, in a political discourse;
- Discrimination on the ground of sexual orientation was commonplace in discussion of political issues; moreover, totally unsubstantiated parallels were drawn between this topic and issues of education (Asaval-Dasavali newspaper);

Topic of the Week

Video featuring sexual scenes on social networks

One of main topics of the week was the TV coverage of the video featuring sexual scenes, which was released in social networks for discrediting a human rights defender, Girogi Paresishvili, and sibility of Media event that unfolded thereafter.

> The release of footage of private scenes in social networks is a clear breach of both the legislation and ethical standards, however, after such fact occurred a question

emerges: How correct is for media to identify what type of sexual intercourse was featured in the surreptitious footage released in the Internet. The subtlety of this topic depended on finding the right balance between the public interest and the protection of privacy - the video contained homosexual scenes whilst the target of the footage claimed it was fabricated. Given that Giorgi Paresishvili publicly, including via media, accused senior public officials, namely, the

Topic of the Week

- Hate speech applied both by respondents and journalists towards people mainly stemmed from unacceptability of opinions and actions rather than ethnic origin and/or religious belief or sexual orientation of addressees; in this regard the Asaval-Dasavali newspaper was again in the lead;
- In terms of ethnic discrimination, dominating topics were anti-Chinese attitudes and homophobic assessments;
- In terms of religion, the reporting period saw reports on prejudices (Kviris Palitra newspaper) as well as attempts to provide explanations of prejudices (Rustavi 2; P.S.);
- Topics of the week were surreptitious video featuring sexual scenes of a journalist Girogi Paresishvili and Patriarch's initiative about criminalization of abortion. Media covered the former topic in a neutral manner whereas failed to provide opinions of representatives other confessions about the latter topic.

deputy interior minister, the deputy chief prosecutor and the advisor to the prime minister of striking a corrupt deal and claimed that the release of fabricated video was a retaliation from them, it is natural that there was a public interest for the society to know what kind of surreptitious filming was used to blackmail Paresishvili.

It must be noted that the broadcast media covered this topic as delicately as possible, in the context of a protest rally staged to demand the protection of privacy, and basically avoided directly identifying that the video contained homosexual scenes.

Kavkasia TV channel's news program, 4 May

The most balanced report on the mentioned topic was produced by the Kavkasia TV channel. It only reported that the video of sexual intercourse among three persons was released against Paresishvili, without identifying the gender of persons concerned, which would have hinted about the type of sexual relationship.

The source of that footage – kvercxebi.com, which was blocked some time later of the release of the video, was identified visually in the report. The report did not contain that episode of the incident that occurred during the protest rally, in which several citizens verbally abused participants in the rally demanding the protection of privacy, by calling them "pederasts." The fact of verbal abuse was only mentioned in the text of the author of the report.

Channel 9, 3 May

In contrast to Kavkasia TV channel, the news program of Channel 9, specified that the video released by social networks featured the sexual intercourse among two men and one woman, thereby identifying a homosexual nature of the relationship.

The report almost entirely beeped swear words of several citizens abusing human rights defenders during the protest rally, except one episode in which one of the citizens inquired about a religious belief of one of participants in the rally:

"Are you Christian? Go and at least read treatises of John Chrysostomto. You..."

It should be noted that this episode in which Christianity is pitted against the right to protect sexual life of a person was not broadcast by any other TV channel. It is desirable for media to avoid establishing such stereotypes. http://www.myvideo.ge/?video_id=2029299

Imedi TV, 4 May Imedi's news program unjustifiably linked the rally protesting against surreptitious filming of private to a religious topic. The presenter of the news program explained the dissatisfaction of several citizens with the rally of human rights defenders in the following way:

"The dissatisfaction was caused by the fact that the rally was held just days before the Easter."

It is worth noting that none of respondents in the report made such a comment and even if they did, it would have been irrelevant and speculative in light of the main topic which concerned the protection of privacy,



on the one hand, and blackmailing of that person who accused senior officials for corruption, on the other.

The report of Imedi news program also included the episode where rally participants were called "pederasts."

Rustavi 2 news program, 4 May

Rustavi 2 covered the video footage released in social networks in the context of similar videos featuring homosexual scenes, which were released by the prosecutor's office in January, and placed an emphasis on the fact that in the January footage faces of participants were blurred in contrast to recent footage released in social networks now.

Giorgi Gabunia, presenter: "In January the whole of Georgia watched scenes featuring intercourse of homosexual men and public figures although the faces of people in that Continued on p. 15

Hate Speech

In the reported period, hate speech was used both by media representatives and respondents. In terms of respondents, journalists either agreed to such manifestation or left them without reaction.

It should be noted that the hate speech stemmed from unacceptability to opinions and actions rather than ethnic origin and/or religious belief or sexual orientation of addressees, although discrimination on the ground of religious belief and sexual orientation was also observed to some extent. In terms of unacceptability of opinions, the subject of hate speech from an Asaval-Dasavali newspaper journalist was the historian Lasha Bakradze because of his criticism of the phenomenon of Stalinism; in terms of unacceptability of actions, the subject of hate speech of the actor Dima Jaiani was the United National Movement (UNM) because of the president vetoing the amendment to the Law on Common Law Courts; in the last case the subject was not identified at all.

<u>Asaval-Dasavali newspaper; 29 April – 5 May</u>

The journalist of Asaval-Dasavali paper, Giorgi Gigauri, used derogatory words – "immoral primitive," "hopeless cretin," "villain," "degenerate" - when referring to the historian Lasha Bakradze thus inciting hatred towards him.

The title of the interview with Dima Jaiani itself - "UNM members, beware, we will crash you!!!" contains hate speech towards the politically unacceptable group whilst the interview discriminates concrete representatives of UNM, including on the grounds of sex, ethnic origin, physical appearance and incites hatred both against concrete representatives of the party and the party collectively (interviewer was the journalist Giorgi Gigauri):

> **Dima Jaiani:** "How long can this fake physiognomy of that Giorgi Kandelaki be watched?!"

"Tell me folks, how long should we watch that Akuki [mocking name - Akaki] Minashvili of unidentified origin and sex?!"

Maestro, talk-show Kviris Argumenti, 1 May

Even though a guest of Kviris Argumenti, the Chairman of United Trade Unions Irakli Petriashvili, does not identify a public official who, according to his information, sexually abuses his subordinate women, but he incites hatred towards that official when he deems lynching (burning a person) as appropriate punishment in such a case.

> **Irakli Petriashvili:** "I know how in one of Tbilisi entities the manager sexually abuses females... In this regard, well, hard to say but, the society must burn that person, at least, in the prison..."

The journalist does not react to such statements of the respondent and only inquires whether relevant bodies are aware of the behavior of that of official.

Anti-China

media representatives and respondents are mainly manifested in the context of social and economic conditions and propertyrelated issues. In this regard, an especially actively exploited topic is the construction carried out by a Chinese company in the territory of Tbilisi sea, dubbed by a segment of media, politicians and separate public figures as the Chinatown and Chinese settlement

Kavkasia TV channel, talk-show Spektri, 3 May

Talking with an independent candidate about the interim election conducted in Tbilisi's Nadzaladevi district, the presenter of the talk show Davit Akubardia <u>Asaval-Dasavali; 29 April – 12 May</u> speaks about a Chinese threat:

Davit Akubardia: "If we do not assist one another, a foreign force will indeed seize Georgia; I often go to the Tbilisi sea and seeing an intensive construction works breaks my heart what on earth we need Chinese here. the entire city is full of unemployed." http://www.myvideo.ge/? video_id=2028612

The topic of Chinatown is used by the presenter of the talk show Gamis Studia. Nino Ratishvili too:

Kviris Chronika newspaper; 3-12 May

Gia Kruashvili from "Free Georgia" presents Chinese as a threat to lose Georgia, while journalist Gela Zedelashvili openly

Anti-Chinese attitudes reported by both expresses his support to what the respondent discusses.

> Gia Kruashvili: "Look, Chinese have enclosed the entire Varketili district, the entire Tbilisi sea, who will be left in Georgia? I intend to go now to the Tbilisi sea and enclose a plot of land for a house. I know, I will be visited immediately by people with bludgeons whereas a word is not said to any of those Chinese."

Gela Zedelashvili: "I will come with you."

Tkabladze, Actress: Asmat "Dear Prime Minister, task someone to find out what is happening in the middle of Tbilisi, why should naked Chinese run around here."

Asaval-Dasavali; 29 April – 12 May

A writer and ethnographer, Koba Arabuli, draws unjustified parallels between the invasions of Shah Abbas and the current arrival of Chinese. Indians and Arabs in Georgia.

Kviris Kronika, 3-12 May

A ruinous system of awarding citizenship must be abolished. One cannot receive German citizenship if he/she does not know German. In Kharagauli there are Chinese with Georgian surnames - Chkheide and Tsereteli. Soon we will probably have Chinese Bagrationis"

Journalist Gela Zedelashvili shares the respondent's attitudes:

Ethnic discrimination dominated in the context of property rights again.

> **Dima Jaiani:** "That Saakashvili wanted to turn the country into Singapore not only in words but by deeds has been revealed

Miscellaneous

<u>Alia, 2.05 – 7.05</u>

Interview of journalist Gela Zedelashvili with the then Agriculture Minister, Davit Kirvalidze. titled "Why does the government not change laws?", is dedicated to issues of land privatization. A discriminative spirit of the interview. manifested in the editorial position of the journalist, is reinforced by photos featuring two men of Asian appearance, including one wearing turban.

The journalist explains the respondent's statement that lands were basically sold by private persons with the mistrust towards the former government ("Because private persons did not have support of the previous government and lost hope").

In contrast to other materials published in Alia in which a respondent and a journalist share common positions, in this particular case discriminative attitudes are mainly manifested by the journalist Gela Zedelashvili. Gela Zedelashvili: "We must speak about Indians and Chinese. Bidzina Ivanishvili himself tries to avoid this topic. However, these foreigners have inundated Georgia."

"Stop that, pal. On the very day they arrive in Georgia they can buy land, is that fair?"

Kavkasia TV channel, talk -show Spektri, 30 April

The presenter of Spektri, Davit Akubardia, views the establishment of social justice to balance different ethnic groups as a correct step, thereby discriminating ethnic groups.

> Davit Akubardia: "The key of this leftwing ideology is social justice. If this does not become dominant either Turks will swallow us up or Pakistanis and the country will merely demise." http:// www.myvideo.ge/? video id=2058759

Based on unverified information, Elizbar Javelidze hyperbolizes the threat of losing Adjaria and it becoming dominated by Turks.

Kviris Palitra, 29 April – 5 May

In an interview, "You are a good man but are vou Christian?!". Giorgi Okruashvili asserts that he was dismissed from the Azerbaijani limited liability company, Kavkaskabel, because of being an Orthodox Christian. Such an action is punishable under the Georgian legislation; however, the author of the publication, journalist Mari Zandukeli, has not undertaken relevant measures to verify the fact. Even though the article contains a brief comment, enclosed to the interview in the form of P.S., of a founder of the company, Elchin Humatov, who accuses Giorgi Okruashvili of lying and promises the journalist to talk to her extensively on this topic next week, it does not ensure a fair balance of opinions in this concrete case.

First, the journalist should have waited for a promised extensive comment from Elchin Humatov, allowing the

It should be noted that there is no clear line drawn between religious and ethnic discriminations, as well as between ethnic, religious and sexual discrimination, in media and public domain, which is mainly manifested in the political discourse.

journalist to double check the fact, and to publish the material only after that. The journalist should have also learned from other company employees whether they encountered any problems in their jobs on religious, ethnic or other grounds.

In addition, the article offers assessments of the expert Mamuka Areshidze in which the expert engages in generalization and draws unjustified parallels not only on religious but also on ethnic ground, thereby portraying investors as oppressors of Georgians.

Asaval-Dasavali; 29 April – 5 May

Asaval-Dasavali continues to manipulate with the topic of Georgian president's origin. This time around this topic is used by the actor Dima Jaiani. The respondent segregates rights on the ground of ethnic origin.

Dima Jaiani: "Vakhtang Kolbaia is a man, a Georgian man and how dare non-Georgian Saakashvili accuses him of treason of Georgia!"

Even though the entire interview from its content to its title "UNM members, beware, we will crash you!!!" is built on hate and discrimination, the above quoted statement of the respondent is followed by a remark of the journalist Giorgi Gigauri that Dima Jaiani will be accused of xenophobia because of these words. It should be noted that the journalist Giorgi Gigauri is himself distinguished for his xenophobic comments however such a reaction to the respondent's statement from his part may only be considered as exception. In response to the journalist's remark, Dima Jaiani still continues to apply the same rhetoric.

Dima Jaiani: "Let Armenian president be president in Armenia! Georgia must have a Georgian president! Can you imagine Armenia having a Georgian president?! Is Georgia short of Georgians in order not to have the Armenian president?!" http://www.asavali.ge/archive/2013/967/files/1-41pm5.pdf

Mamuka Areshidze: "It is also noteworthy that the former government allowed the domination of financial and business groups of several neighboring countries over Georgia. Very favorable conditions were created for several foreign firms. In such environment they act with impunity... The result of unfavorable conditions for Georgians in Georgia is that the entire Europe is full of Georgians. They have to tolerate myriad humiliations there, however, that can be tolerated abroad, not in own homeland! I can understand when a Georgian is required to change his/her religion in an Islamic country but when he/she is required the same in his/her homeland, that is something unacceptable and very irritating.

As far as I know, our citizens working for Chinese company constructing the Olympic village are also put in unfavorable conditions... I will not tolerate the oppression of Georgians no matter where the investor is from."

Mamuka Areshidze: "The result of unfavorable conditions for Georgians in Georgia is that the entire Europe is full of Georgians. They have to tolerate myriad humiliations there, however, that can be tolerated abroad, not in own homeland! "

Since Giorgi Okruashvili intends to lode a complaint and consequently the court must establish factual circumstances, it would be desirable for the journalist to find a relevant expert for comments. Lawyers' assessments of how such cases are regulated; information from the Public Defender's Office or a court on how widespread is the discrimination on religious ground from employers, would add more clarity to the issue.

Imedi, 6 May

Imedi TV news program, Chronika, reported about the consecration of monastery in Kvemo Bolnisi village and the issue of proselytism in a settlement populated by ethnic Azerbaijanis. Statements by Father Ephrem

about ethnically complicated situation and the blood spilt for the religion, are discriminative towards those citizens of Georgia who have different ethnic origin and religious beliefs.

> Father Ephrem: "Over the centuries this church was inactive. You are aware of a very complicated situation in terms of ethnicity here – Georgians and Christians are a minority here. This is a current reality. Our ancestors fought during centuries here to save the belief and the homeland and in fact, this land is saturated with blood. Therefore, it is important for a Georgian church to operate in this very area where Georgians no longer live actively. We have established the monastery of monks here to take a constant care of the church."

The report provides a comment of a religious servant alone and the journalist generalizes on this ground:

> Nutsa Trapaidze: "In the village where almost no Georgian lives, from now on the religious services will be held in Georgian every weekend." http://www.myvideo.ge/? video_id=2030552

The newspaper expresses its editorial policy through quoting Deacon Grigol Gogichadze, whose statements were published in another newspaper, Kviris Palitra, a week before, and who refers to the United National Movement as a Satanist sect:

Construction of a mosque

The issue of construction of the mosque in Batumi was again covered with reference to the results of the public opinion poll conducted by the Patriots Alliance. In addition to the Media Union Obiektivi, which is closely affiliated with the Patriots Alliance, this topic was also covered in the Rezonansi newspaper in which professional standards were violated.

Rezonansi, 3 May

Even though the information published in Rezonansi, titled "95% of Batumi residents are against the construction of mosque," belonged to the news agency MediaNews, by publishing it the newspaper shares the responsibility for the content of publication.

The publication violates those minimal standards which must be taken into account when reporting results of an opinion poll. Namely, the report must indicate the name of organization that commissioned the poll, the financier of the poll, the number of respondents, margin of error, geographic area in which and the period when the poll was conducted, precise wording of questions, the survey methodology. From these minimum requirements, the publication contained only the number of respondents, the geographic area and the implementer of the poll and lacked such necessary components as the name of organization that commissioned the poll, the financier of the poll and precise wording of questions.

A legal question as to how justified is to take decisions on issues concerning minority rights based on the opinion of the majority is a matter of separate discussion and it would be expedient to cover the mentioned survey from this angle.

Obiektivi, 2 May

In discussing the construction of the mosque, the talk show Ghamis Studia focused on the necessity to take into account the opinion of the majority. Apart from a phone-in discussion of this attitude by a representative of the Patriots' Alliance, Ada Marshania, the analogous position was expressed by the presenter of the program, Nino Ratishvili.

Nino Ratishvili: *"If this is not taken into account by the new government, will that be serious?"*

At the end of the program, the presenter congratulates the population on the results of the poll:

> **Nino Ratishvili:** "I want to congratulate once again; this poll has been completed in Batumi and I do hope that this will not become yet another watershed between people and the new government." http://www.obieqtivi.net/tv1.php?id=11794

Prejudices

<u>Kviris Palitra, 29 April – 5 May</u>

An article of a journalist Zviad Sekhniashvili, "Listen grandpa, look at God what it does with enemy," dedicated to a religious servant, Father Giorgi Basiladze, spreads prejudices.

The journalist describes how several persons, on their way to Zugdidi, dropped at Father Giorgi's place who asked the guests to stay. Having refused to stay and bidding farewell to the religious servant, they failed to start a car. According to the journalist, the car started only after Father Giorgi made the sign of the cross upon the car.

The second episode concerns the wine which, according to the journalist, Father Giorgi gave them together with bread, warning not to try it until they have reached home. According to Zviad Sekhniashvili, they decided to try the wine on their way to Kutaisi but they were not able to do so because the wine tasted like vinegar. *"Having reached home, we tried the wine again and Glory to our God, it was a pure wine, the taste of vinegar disappeared altogether!"* the journalist continued.

Prejudices

Rustavi 2, P.S. 5 May

A report in the P.S. program was a sort of attempt to dispel those prejudices which a segment of believers entertain in relation to electronic ID cards. The presenter of the program, Davit Kikalishvili, noted the video clip produced by the Justice Ministry in which it pledges that three subsequent figures 6, or 666, will not occur on ID cards. The presenter asks what is behind this campaign, *"the Bible, the protest against global control or anti-western and anti-Jewish propaganda which is a hidden call towards isolation?!"*

Arguments of religious persons and believers are considered in detail in the report and counter-arguments of the Justice Ministry are also provided:

Father Iobi (Episcope of Ruis-Urbnisi): "I is an English word meaning me in Georgian whilst D is a shortened form of demon. This means I am the demon."

Levan Samadashvili, chairman of agency for the development of state services: *"ID means an identification document in English."*

Father Iobi (Episcope of Ruis-Urbnisi): "What is surprising is that Jesus Christ was betrayed for 30 pieces of silver, this card also costs 30 GEL."

Father Zosime: *"The number of a person having created a code of beast of global controlling system and the number of the beast is the same - 666."*

Despite the explanatory nature of the report, at the end of the report the author of the report, Giorgi Gvishiani, makes an assumption that if the number of the beast is a bar-code, then we voluntarily accept the number of the beast daily when buying something.

> **Giorgi Gvishiani, journalist:** "If the number of the beast mentioned in the Apocalypse is a bar-code which is engraved on food products, then it turns out that we voluntarily agree to accept the number of the beast. Consequently, if we want to save our souls we must say no to any trade - be it in cash or by plastic card."

True, the author of the report applies a journalistic method to show the audience the absurdity of such attitude towards the issue, but it would have been better if the journalist had noted that only verbally in order to exclude any possibility of someone taking a hypothetical assumption for a real fact.

Deported Meskhetians

Meastro, Politmetri, 29 April

The talk show Politmetri dedicated a program to the topic of deported Meskhetians.

It is noteworthy, that the topic of deported Meskhetians is discussed by respondents in the context of ethnic origin, whether they are Georgians or non-Georgians, rather than in the context of the right to restoration of justice. This attitude is revealed by supporters of repatriation (Goga Khaindrava) as well as opponents (Manana Nachkebia, "Muslim Meskhetians who are indeed of Georgian ethnicity").

Goga Khaindrava's last phrase about the belief of deported Meskhetians is discriminatory because he says that the religious affiliation of people is not the expression of their will but the imposed factor.

Even though a respondent, Jondi Baghaturia, notes correctly that neither the ethnic origin nor religious belief of those people means anything for him, he justifies the decision of the Soviet regime on forceful exile of Meskhetians when talking about anti-Georgian sentiments of deported Meskhetians and moreover, offers that allegation as an established fact.

Jondi Baghaturia: *"The main reason of their resettlement from here was their anti-Georgian sentiments, pro-Turkish sentiments, let's say so... I do not know whether*

they are Georgians genetically, at least 80% of them are Turks because the Turkish occupational regime, in due time, resettled ethnic Turks from the middle of Turkey to Meskheti in order to upset a demographic balance." http://www.myvideo.ge/?video_id=2029394

Manana Nachkebia from the New Rights political party segregates Meskhetians into ethnic Georgians and those who served the Soviet KGB.

Manana Nachkebia: "Despite our attitude towards the restoration of historic justice, you know perfectly well that they can be divided into two segments – Muslim Meskhetians who are indeed of Georgian origin genetically and for whom this is a historic homeland, and people who were very well used by the Soviet KGB against Georgia." http://www.myvideo.ge/?video_id=2036367

The presenter Nino Zhizhilashvili correctly argues with the opponent of repatriation, Jondi Baghaturia, about the injustice conducted against Meskhetians though, at the same time, identifying human rights defenders by their ethnic origin (Georgian) is unjustifiable.

Nino Zhizhilashvili: "That is why, human rights defenders in this country, <u>ethnically</u> <u>Georgian human rights defenders</u> say that the stopping of this process will be unfair towards concrete persons."

When Jondi Baghaturia speaks about legal responsibility and legacy of the Soviet Union, which is a legitimate topic, the presenter again shifts the topic into an ethnic context and with an apparent hint to Stalin, says that *"ethnic Georgians also contributed to this process."* Jondi Baghaturia, in this case, absolutely correctly points to the presenter that it is not correct to divide people by the DNA analysis and ethnicity. http://www.myvideo.ge/?video_id=2029434

However, for his part, Jondi Baghaturia draws unjustified parallels between the repatriation of Meskhetians and the conditions of refugees in the country, especially considering that the state does not have a legal obligation of restitution towards deported people.

Jondi Baghaturia: *"We have up to 300,000 refugees in Georgia... These people are homeless. Now, is it not better to take care of our people living here?"*

Based on arguments of opponents, namely, the issue of refugees, the presenter puts a question to the deputy justice minister, which is legitimate but the question about the refugees smacks of emotional speculation, especially considering that the state does not have a legal obligation of restitution towards people with a repatriate status:

Nino Zhizhilashvili: "The opponent has posed the question like that... How can the country having hundreds of thousands of refugees take care of the resettlement of people from another country? What can you say about that? Refugees may be watching you now and they might be disappointed that they lack the care of that scale at this stage which they would like to receive."

An interview of journalist Gela Zedelashvili with a representative of Free Georgia, Gia Kruashvili, is saturated with homophobic statements:

Gia Kruashvili, Free Georgia: "I do not see in Georgia a Georgian walking proudly, only pederasts walk proudly here. They promote those pederasts so that I am nearly to change sex, f..ck them! I do not want them die or be killed by the firing squads. Let them be for themselves, why are they talking to me about them on TV daily?"

An interview of the journalist Tamar Okruashvili with the chairman of the party of national ideology, Zurab Gagnidze, also contains homophobic and discriminative statements ("he is exposed of being blue") and based on rumors, describes an incident which the journalist leaves without comment and expresses the editorial position in the title of the interview – "Several teachers exposed of being blue were beaten by students." The term "blue" is an offensive term for gays in Georgia.

> Zurab Gagnidze: "Three days ago several university teachers who were exposed of being blues were beaten by students. That does not happen only once! Representatives of the Liberty Institute stepped in to protect those beaten teachers saying one should not behave like Kurtanidze did. I will not disclose names of those blues, it is not comely. This is a well known fact in the university. Tevzadze took precautions and after that incident removed all the swords, axes and knives from the history cabinet into his cabinet and keeps them there."

An article of journalist Zaza Davitaia, "Anjelika and the King," is discriminative on the grounds of ethnicity and sexual orientation. It refers to the president of Georgia as Saakov whilst to the leader of the organization Patriots, Giorgi Mazmaniani, as Anjelika. The entire article which is dedicated to the United National Movement and its leader, is homophobic and contains offensive and degrading evaluations.

> Zaza Davitaia: "Saakov-Mazmanian's National Movement with its non-traditional orientation takes the country towards the abyss!"
